**1. Call to Order and Pledge of Allegiance**

This meeting was called to order at 7:10 pm.

**2. Program: Newport's Little Red Schoolhouse by Laura McCrillis Kessler**

**3. Consent Agenda Approval**

Approval of the Executive Committee Minutes, Secretary Report and Treasurer Report was moved by Jack Liberman and seconded by Anita Hawkings and unanimously approved.

**4. Old Business**

- 1. Pier Bridge Project:** Jackie Cote informed us that the latest change order for the Wrights/Pier Bridges project requires the total replacement of the top cords of Wrights Bridge, for which an additional \$23,000 needs to be raised. These rotted boards bring into question the safety of the bridge for public use, and a load bearing test will be performed soon. If the money cannot be found and allow completion of this work this year, the cost will increase about an additional \$20,000 for remobilization fees. Aside from this setback, the work should be 60% complete by the end of September. See the September Pier Bridge report for full details.
- 2. LCHIP Grant:** The NHS voted to hire a grant writer in order for the NHS to put forth the best possible application for a grant to purchase the Nettleton House and make necessary repairs. We should hear the results by mid to late November. If the grant does not come through, we will still move forward with the purchase of the property, which will require more work from NHS members to support this venture. Catherine Hogan was hired as grant writer for this project, and as per her contract, which was approved by the NHS membership, the final fee was \$1,000.00 due to additional hours required to complete the grant process.

## 5. New Business

### 1. 2010-2011 Ballot

The NHS annual election occurs at the October meeting, this year on October 18 and held at the South Congregational Church Fellowship Hall after the October program. The nomination committee presents the following slate for the 2010-2011 ballot: President: Cathryn Baird, Vice President: Todd Coull, Treasurer: Jackie Cote, Secretary: Mary Lou McGuire, Museum Committee: Christina O'Brien, Brenda Curtis, and Larry Cote. Room for write ins and nominations from the floor to be included.

### 2. Membership Drive

The annual NHS membership drive begins in October, so watch for the renewal letter! President Baird urged all members to reach out to friends and acquaintances and ask them to consider joining our organization. We have grown from 13 members to 139 members over the past three years, and we would like to see membership growth continue.

### 3. Fundraising:

Apple Pie Craft Fair: Jackie Cote reported that we had a phenomenal day at this year's Fair, making \$1,085.00. Of that \$902.00 was from our new ornament: Skating on the Common. In fact, we sold over half of our new stock in the first two weeks, and have reordered more. (Secretaries note: many thanks to Stan Sweeney for coming up with the design idea for these ornaments!)

Fall Sales Schedule: Jackie also informed the membership that the NHS would once again be setting up shop in the foyer of the Sugar River Bank during the months of November and December. Please watch for us the first Friday and Saturday in November, and use this opportunity to purchase holiday gifts. This is our biggest fundraising opportunity of the year, and we ask for your support.

LAC Gallery of Gifts: NHS ornaments and cemetery impressions will be featured in this year's Gallery of Gifts.

## 6. Announcements

1. Board of Selectmen presentation: The NHS Cemetery Committee will make a presentation to the Board of Selectmen on September 20 to request their support of the restoration and preservation of Pine Street West Cemetery. NHS members are urged to show their support by attending.
