## 3. Program: New England Gravestones by Kai Nalenz

The Historical Society thanks Kai Nalenz of Gravestone Services of New England, located in Bedford, NH, for his presentation on the history and preservation of New England gravestones. His interesting talk covered the care and preservation of sandstone, slate, marble and granite stones and monuments, as well as amusing stories about his adventures in local cemeteries. Mr. Nalenz received his training from the international Association of Graveyard Studies, established in the 1977, and headquartered in Greenfield, MA. He has worked throughout the northeastern United States, from New York to Monhegan Island to Cape Cod. Attendance: 57.

He provided invaluable information and assistance on applying for the grant. Mentioned were examples of work that had previously occurred in the building, such as the replacement of the original plaster with drywall. The Historical Society hopes to purchase the building and move in by the first of the year 2011.
